I have read this notification form with my attorney. My obligation to register has been explained to me. I have been specifically informed and understand that:

1. The court has classified me as a \_\_\_\_\_, \_\_\_\_\_ initials. See 42 Pa.C.S. § 9799.23(a)(6).
2. I have a duty to register under 42 Pa.C.S. § 9799.10 et seq. \_\_\_\_\_ initials. See 42 Pa.C.S. § 9799.23(a)(1).
3. If I am sentenced to a period of incarceration in a county or state correctional facility, the court shall require me upon sentencing to immediately report to the Office of Probation and Parole to provide the information set forth in 42 Pa.C.S. § 9799.16(b).

4. If I am sentenced to county intermediate punishment that is restorative or restrictive where I am not sentenced to incarceration or a work release facility; or county probation, I shall provide the information set forth in 42 Pa.C.S. § 9799.16(b) by appearing at an approved registration site within 48 hours of being sentenced. If I fail to appear, the Pennsylvania State Police shall be notified.

5. The information that I shall provide or verify under 42 Pa.C.S. § 9799.16(b) is:
  - a. Primary or given name, including any alias I use, nickname, pseudonym, ethnic or tribal name, regardless of the context used and any designations or monikers used for self-identification in internet communications or postings.
  - b. Designations I use for purposes of routing or self-identification in internet communications or postings.
  - c. Telephone number, including cell phone number and another designation used by me for purposes of routing or self-identification in telephonic communications.
  - d. Valid and/or purported social security number(s).
  - e. Address or each residence or intended residence, whether or not the residence or intended residence is located within this Commonwealth and the location at which I receive mail, including a post office box unless I am a transient.
  - f. If I am a transient, information about my temporary habitat or other place of abode or dwelling, including but not limited to, a homeless shelter or park. In addition, I shall provide a list of places that I eat, frequent or engage in leisure activities and any planned destinations, including those outside the Commonwealth of Pennsylvania. If I change or add to the places listed under this paragraph during a monthly period, I shall list these when registering as a transient during the next monthly period. In addition, I shall provide the place I receive mail, including a post office box. If I am classified as a Sexually Violent Predator, I shall state whether I am in compliance with 42 Pa.C.S. § 9799.36 (relating to counseling of Sexually Violent Predators). This duty to provide information set forth in this subparagraph shall apply until I establish a residence and am no longer a transient.
  - g. With regard to temporary lodging, I must provide the specific length of time and dates during which I will be temporarily lodged.

- h. A passport and documents establishing immigration status.
- i. Name and address where I am employed or will be employed. If I am not employed in a fixed workplace, I shall provide information regarding general travel routes and general areas where I work.
- j. Information regarding occupational and professional licensing, including type of license held and the license number.
- k. The name and address where I am a student or will be a student.
- l. Information related to motor vehicles I own or operate, including watercraft and aircraft. I shall provide a description of each motor vehicle, watercraft or aircraft. I shall provide a license plate number, registration number or other identification number and the address of the place where the vehicle is stored. I shall provide my license to operate a motor vehicle or other identification card issued by the Commonwealth of Pennsylvania, another jurisdiction or a foreign county.
- m. Actual and purported date(s) of birth.
- n. Sign a form acknowledging my obligations under 42 Pa.C.S. § 9799.23.

- 6. I shall appear at an approved registration site to provide or verify the information set forth in 42 Pa.C.S. § 9799.16(b) (which is explained in paragraph 5 above) and to be photographed quarterly/semiannually/annually at a date determined by the Pennsylvania State Police ("PSP").
  - a. If I am classified as a Sexually Violent Predator, I must also state whether I am in compliance with 42 Pa.C.S. § 9799.36 (relating to counseling of Sexually Violent Predators). See paragraph 18 below.
  - b. I must appear within three business days of becoming a transient at an approved registration site to be photographed and provide or verify the information and must continue to appear monthly until I establish a residence and am no longer transient.

- 7. The PSP shall send me a notice by first class mail at my last reported residence or location, including a post office box.
  - a. The notice shall be sent not more than 30 days nor less than 15 days prior to the date I am required to appear at an approved registration site.
  - b. The notice shall remind me of my responsibilities and provide a list of approved registration sites.
  - c. Failure by PSP to send a notice or me to receive a notice shall not relieve me of my responsibilities.
  - d. The occurrence of a natural disaster or other event requiring evacuation of residences shall not relieve me of my responsibilities to register or any other duty imposed upon me.

- 8. If I fail to appear at an approved registration site within ten days of the date provided by the PSP:
  - a. I may be subject to prosecution under 18 Pa.C.S. § 4915.1.
  - b. The PSP shall notify the municipal police department where I have a residence, am employed or enrolled as a student.
  - c. The municipal police shall locate and arrest me.
  - d. The PSP shall also notify the United State Marshalls Service of my failure to appear.

9. Within three business days of one of the following occurring, I shall appear at an approved registration site to provide current information:
- A change in name, including an alias.
  - A commencement, change, or termination of residence; or failure to maintain a residence which makes me a transient.
  - Commencement of employment, a change in the location or entity in which I am employed or termination of employment.
  - Initial enrollment as a student, a change in enrollment as a student or termination as a student.
  - An addition and a change in telephone number, including a cell phone number, or termination of telephone number, including a cell phone number.
  - An addition, a change in and termination of a motor vehicle owned or operated, including watercraft or aircraft. I must provide any license plate numbers and registration numbers and other identifiers and an addition to or change in the address of the place where the vehicle is stored.
  - A commencement, change or termination of temporary lodging. I must provide the specific length of time and the dates during which I will be temporarily lodged.
  - An addition, change in or termination of e-mail address, instant message address or any other designations used in internet communications or postings.
  - An addition, change in or termination of information related to occupational and professional licensing, including type of license held and license number.

10. I shall appear in person at an approved registration site no less than 21 days in advance of traveling outside of the United States and shall provide the following information:
- Dates of travel, including date of return to the United States.
  - Destinations.
  - Temporary lodging.

11. The requirements to appear in person set forth in 42 Pa.C.S. §9799.15(e), (f), (g) and (h), see paragraphs 6 and 9 above, do not apply when I am:
- Incarcerated in a correctional institution, excluding a community contract facility or community corrections center;
  - Subject to a sentence of intermediate punishment which is restrictive and where the individual is sentenced to a period of incarceration.
  - Committed to an institution or facility set forth in 42 Pa.C.S. § 6352(a)(3) which provides the individual with 24-hour-per-day supervision and care; OR
  - Committed to and receiving involuntary inpatient treatment in the State-owned facility or unit set forth in Chapter 64 of Title 42.

12. I have a duty to register with authorities in another jurisdiction within three business days of:

- a. Commencement, change, or termination of residence; or failure to maintain a residence which makes me a transient.
- b. Commencement of employment, change in the location or entity in which the sexual offender is employed or termination of employment.
- c. Commencement of enrollment as a student, a change in enrollment as a student or termination of enrollment as a student.

13. The court will order that my fingerprints, palm prints, DNA sample and photograph be provided to the PSP.

- a. Register with the PSP, verify my address or be photographed, I may be charged with violating 18 Pa.C.S. § 4915.1 and sentenced to a mandatory term of imprisonment as provided in 42 Pa.C.S. § 9718.4.
- b. Provide accurate information when registering, I may be charged with violating 18 Pa.C.S. § 4915.1 and sentenced to a mandatory term of imprisonment as provided in 42 Pa.C.S. § 9718.4.

- b. Parole or a sentence of probation; or
- c. A sentence of State or county intermediate punishment in which I am not sentenced to a period of incarceration.

17. I understand that my period of registration shall be tolled for the period of time in which I am:

- b. Subject to a sentence of intermediate punishment which is restrictive and where the individual is sentenced to a period of incarceration;
- c. Committed to an institution or facility set forth in 42 Pa.C.S. § 6352(a)(3) that provides me with 24-hour-per-day supervision and care;
- d. Committed to and receiving involuntary inpatient treatment in the State-owned facility or unit set forth in Chapter 64 of Title 42; OR
- e. Incarcerated in a Federal correctional institution, excluding a community contract facility or community corrections center.

18. If I have been classified as a Sexually Violent Predator, when I am not incarcerated:

- a. I shall attend at least monthly counseling sessions in a program approved by the State Sexual Offenders Assessment Board (SOAB).
- b. I shall be financially responsible for all fees assessed from the counseling sessions.
- c. SOAB shall monitor my compliance.
- d. If I can prove to the satisfaction of the court an inability to pay for these counseling sessions, the parole office shall pay the requisite fees.
- e. If I fail to attend counseling sessions, I may be charged with 18 Pa.C.S. § 4915.1 as a misdemeanor of the first degree.
