To vote for an individual candidate of another party after voting a straight party ticket, blacken the oval to the left of his or her name.</p> <p>3. For an office where you may vote for more than ONE candidate, you may divide your vote among the candidates. For such offices votes shall not be counted for candidates not individually marked.</p> <p>4. To vote for a person whose name is not on the ballot, blacken the oval to the left of the line provided, and write the name of the candidate on the line provided for that purpose.</p> <p>5. If you make a mistake, do not erase. Ask for a new ballot.</p> <p>6. Use only the marker provided.</p> <p>7.
