Before DEBITING your account or CHARGING your credit card.

Credit Card Service Is Now Available: Convenience fee is 2.35% of each transaction charged to your card. Or you may deposit a credit card convenience check to your checking account and then DEBIT your account as described below. VISA & Mastercard only accepted.

AFTER JULY 15, 2010 DO NOT TRY TO PAY 2008 DELINQUENT TAXES HERE. THEY MUST BE PAID BY CASH, MONEY ORDER, CERTIFIED OR LOCAL BANK CHECK. YOU WILL NOT RECEIVE A RECEIPT.

2009 DELINQUENT TAXES MAY BE PAID HERE ALL YEAR.



Click on this button to visit Same Day Pay, create a payment account and pay from your checking account using Automated Clearing House service or to charge your credit card.

To apply payment choose "Snyder County Tax" from the drop down list.

SameDayPay is fast, easy, secure and available 24 hours a day 365 days a year. You control the timing on when to make a payment. You can also schedule payments to be made on a specific day in the future. SameDayPay provides a positive e-mail confirmation so that you know your payment has been made and allows you to see 120 days of history on all of your payments. You may debit your bank account for which your account will be charged \$3.00 per transaction by the service company, SameDayPay. Your payment will NOT be receipted until funds clear our bank. Do NOT add the \$3.00 to your payment amount. You MAY call for correct payment amount or your payment will be applied as a partial. Your payment will be credited as of the date funds are actually received by our bank.

The service asks for a map (parcel) number which is in the property description.

Example: 00-00-000 or 00-00-000LT000

Your map/parcel number may be found on any tax bill.
