

### **Mid-West School District 2nd & 5th Graders Learn About Environment & Have Fun**

The Snyder County Conservation District (SCCD) was invited to West Snyder and Middleburg Elementary Schools to coordinate and teach 150 2nd graders several aspects of nature and organize an environmental education competition for 153 5<sup>th</sup> graders in May 2022. SCCD staff, as well as staff from cooperating agencies, visited West Snyder Elementary School in Beaver Springs on May 11 and Middleburg Elementary School on May 13.



#### **Second Grade Presentations:**

In both schools, the topics the students learned about were as follows: soils, trees, song & game birds, and birds of prey.

Middleburg Elementary students also listened to a presentation on macroinvertebrates. Each second grader took home a mini-greenhouse with vegetable seeds planted into soil, a bag of bones from an owl pellet, a bird call, and other activity books inside a draw string backpack. Trees were handed to West Snyder 2nd graders and a magnifying glass was given to Middleburg 2nd graders.

### Fifth Grader Envirothons:

At each school, a “Fifth Grade Envirothon” was held. Students were assigned into teams of three to five. Weeks before the event, the students and teachers were given materials to read, discuss and study regarding soils & agricultural conservation practices, aquatics, forestry, and wildlife. Middleburg 5th graders also had information about vernal pools.

After each school’s Envirothon, they were given the correct answers to many questions. Each group’s answers were scored and the top teams at each school were given prizes.

Lauren Cheran, SCCD Watershed Specialist, coordinated both sets of activities. Several of her fellow SCCD colleagues, a local aquatics scientist, and individuals from USDA-NRCS (Natural Resources Conservation Service), Penn State Extension, and PA Department of Conservation & Natural Resources’ (DCNR) Bureau of Forestry helped with the five activities.

SCCD has given presentations to young people in schools, at school sponsored events and at other events throughout its history.
